NOTICE:** The Executive Officer read the Convening Notice as follows:

A Parish of St Saviour nomination meeting will be held at St Saviour's Parish Hall on Monday 3 February 2020 at 7.00pm for the following business:

1. To elect a Procureur du Bien Public for a 3-year term of office
2. To elect a Centenier for a 3-year term of office

All electors are welcome to attend.

A nomination form for each candidate must be produced to the meeting and must be completed by a proposer and 9 seconders who are electors in the Parish.

In each election:

If there are more candidates than vacancies a poll will be held on Wednesday 11 March 2020.

If there are not more candidates than vacancies any duly nominated candidate will be declared elected at the nomination meeting.

To vote in this election you must be registered by midday on the day BEFORE the nomination meeting.

ITEM 1: The Connétable called for nominations to fill the office of Procureur du Bien Public for a 3-year term of office, in accordance with Article 19 of the Public Elections (Jersey) Law 2002.
