Dear Jurat

Election of a Centenier

Pursuant to a certain Act of the Royal Court dated 31 January 2020, whereby it was ordered that an Election for a Centenier be held to elect an officer to complete the term of office of Centenier Christian Julé who had resigned, I presided over an Assembly of Electors of the said Parish which was duly held at the Parish Hall on Monday 24 February 2020.

At this Assembly, which numbered 11 persons, no candidates were proposed.

After the expanse of time required by the Public Elections (Jersey) Law 2002 had elapsed, and as no nominations were forthcoming, the meeting was closed.

I trust the above is a sufficient record to enable you, in your capacity as Returning Officer, to report the outcome of this election to the Royal Court on Friday 13 March 2020, in accordance with the said Act of the Royal Court I shall be present to represent the Parish.

Notwithstanding our failure to find a suitable candidate on this occasion, we will continue to seek a replacement.
