ITEM 1: The minutes of the previous meetings held on Tuesday 26 November 2019 and Monday 3 February 2020 were proposed by Centenier Steven Laffoley-Edwards, seconded by Mrs Lynda Townsend and unanimously agreed by the Assembly.

ITEM 2: To Elect 2 Constable's Officers to fill vacancies in the Vingtaines of Maufant & Sous la Hougue and Pigneaux & Grande Longueville.

On a proposition by Centenier Steven Laffoley-Edwards, seconded by Mrs Lynda Townsend, Mr **Philip Andrew BERRILL** was unanimously elected as a Constable's Officer for the Vingtaines of Maufant & Sous La Hougue.

On a proposition by Centenier Steven Laffoley-Edwards, seconded by Centenier David Hallam, Mr **Seamus FRIEL** was unanimously elected as a Constable's Officer for the Vingtaines of Pigneaux & Grande Longueville.

The Connétable thanked them both for standing for election and to their families for supporting them and stated that their service to the Parish is greatly appreciated.

ITEM 3:

Mr Jacob Shaw addressed the Assembly and explained that he moved to Jersey in 2014 and took up the position of Company Director for Euraco Group Ltd.

First Choice Groceries Ltd has been established as an ecommerce grocery company and will require customers to order their weekly shopping online for deliveries to their door. The warehouse in St. Saviour will be purely a distribution centre; there will be no 'walk-ins' from the street. Sales will not be made to persons underage.

Procureur Richard Le Quesne questioned if there would be an impact on the traffic if customers came to collect their orders but Mr Shaw advised the Assembly that orders would be delivered to the clients and that he expected no more than 6-10 collections a week.

On a proposition by Mr Dariusz Antkowiak, seconded by Mrs Lynda Townsend, the Assembly unanimously agreed to recommend the application be granted.
