**Item 1:** The minutes of the Parish Assembly held on 7 December 2020 were proposed by Patricia Blandin, seconded by Geoffrey Morris and unanimously agreed by the Assembly.

**Item 2:** On a proposition by Centenier Steven Laffoley-Edwards, seconded by Centenier Mike Byrne, **Patrycja Leszczynska** was unanimously elected as a Constable's Officer for the Vingtaine de Maufant.

Although Ms Leszczynska was not in attendance, the Connétable thanked her for standing for election; she stated that her service to the Parish is greatly appreciated and wished her all the best in her new role.

**Item 3:** To clarify, this item was a continuation of the Parish Assembly held in December 2020, which was adjourned after receiving four nominations for three positions on the Roads Committee.

The Connétable announced that, since the nomination meeting, one candidate had withdrawn and, as a result, there was no longer any need for an election.

The Connétable declared Geoffrey John Morris, Peter Blampied and Ian Blandin duly elected as members of the Roads Committee for a period of three years.

The Connétable thanked the newly elected candidates.

All Roads Committee Members were warned to attend the Parish Hall at 9:45am on Friday 30<sup>th</sup> April 2021 to be sworn in via video link with the Royal Court.

The Connétable paid tribute to Geoff Esnouf who has stepped down from office after many years of dedicated service.

Connétable Le Sueur-Rennard thanked everyone for their attendance and closed the meeting at 6.45pm.
