ITEM 1:	The minutes of the previous Parish Assembly held on Tuesday 09 August 2021 were proposed by Lynda Townsend, seconded by Cara Miller and unanimously agreed by the Assembly.						
ITEM 2:	<p>Advocate Christopher Schofield addressed the Assembly to explain that, now that Jersey Cricket is recognised on an international level, the Government is investing in the game and there is a need to install better facilities at the Grainville Cricket Clubhouse</p> <p>It is proposed to open a restaurant with seating up to 150 diners, for both club members and non-club members, and to make use of the outside terrace. Catering will be provided by an outside company.</p>						

Questions were asked about the opening hours of the restaurant; Advocate Schofield explained that it is hoped the restaurant would be open Monday to Thursday 3pm to 11pm and Friday to Sunday 9am to midnight.

Concerns were raised about the volume of traffic and parking but no additional traffic movement is anticipated and there is sufficient parking on site and next to the Rugby playing field to accommodate players and diners.

On a proposition by Advocate M Swann, seconded by Mr D. Blampied, the Assembly unanimously agreed that the 3rd (Restaurant) and 5th (Club) Licences be granted subject to checks being carried out by the Fire Service and Department of Health, and all conditions met.
