




## PARISH OF ST SAVIOUR

<b>ITEM 4:</b>	On a proposition by Centenier Steven Laffoley-Edwards, seconded by Centenier John Richards, JENETTE MADDOX was unanimously elected as Vingtenier for the Vingtaine de la Grande Longueville.
