It is recommended that this be verified with the Parish office beforehand.</p> <p>In the election:</p> <ul style="list-style-type: none"><li>• If there are more candidates than vacancies a poll will be held on Wednesday 8 March 2023</li><li>• If there are not more candidates than vacancies any duly nominated candidate will be declared elected at the nomination meeting.</li></ul> <p>To vote in this election you must be registered by midday on Monday 13 February 2023.</p> <p>In accordance with Article 20, (8) of the Public Elections (Jersey) Law 2002, aforesaid, A nomination meeting shall not be closed less than 10 minutes after it has been opened.</p> <p style="text-align: right;">Kevin C Lewis Connétable of St Saviour</p>
