In conformity with Article 5 of the "Loi (1914) sur la Voirie" to elect twelve Roads Inspectors.5. ITEM 2	<p>Sarah Gomersall CEO of Jersey Cricket Limited addressed the Assembly to put forward an application to extend the outside licensed area at the Boundary by 6 metres by 9 metres.</p> <p>Questions were asked with regards to increased noise. James Robertson owner of the Boundary addressed these concerns and assured the Assembly that any events being held outside would be taken inside at a suitable time in order to keep the noise down. He went on to say that the additional space was more for comfort rather than increasing the occupancy and that the premises are largely enjoyed by the cricket community and their families.</p> <p>On a proposition by Thomas Gales, seconded by Deputy Ferey, the Assembly unanimously agreed that they were happy with the application to extend the outside licensed area at the Boundary.</p> <p>Connétable Lewis warned the Boundary to appear before the Licensing Bench at the Royal Court on Thursday 21 December 2023 to have their application heard.</p>
