<b>ITEM 1</b>	The minutes of the previous Parish Assembly held on 4 December 2023 were proposed by Deputy Ferey, seconded by Roads Inspector Stephen Wyatt and unanimously agreed by the Assembly.



**ITEM 2**

Neil Macdonald, Managing Director of Ghost Kitchen Limited addressed the Assembly, presenting an application for a 1st and 3rd Category Liquor license at Howard Davis Hall.

Ghost Kitchen Limited holds a lease for an initial two year period from the Government of Jersey. The venue is approved for weddings and will operate on an appointment-only basis. The premises include a kitchen, bar, hall area, and a small, terraced area for al fresco dining. Mr. Macdonald assured the assembly that a staff member will always be present on the terraced area, and they will adhere to the no-glass policy within the park.

Connétable Lewis asked the Assembly if they had any questions:-

Question: What is the capacity of the premises?

Answer: The premises will accommodate up to 50 persons.

Question: Will the premises be open to passing trade?

Answer: No, they will be reserved for private events only.

Question: has the applicant considered the implications if a Bailiff's licence is granted for the use of the entire park?

Answer: Yes, they have taken this into account and will coordinate with park authorities to avoid any scheduling conflicts. Additionally, they will ensure proper roping off if simultaneous events occur.

Question: What are the opening hours?

Answer: Operating hours will vary depending on specific events such as breakfast, lunch, or dinner, and they will only be open for the duration of those events and the hours stipulated by their licence but in adherence to both Categories 1 and 3.

Question: Will the premises be open after 1 a.m.

Answer: No, there are no plans to open until after 1 a.m.

Question: If an event extends beyond the park's closing hours, will the company cover the cost of park security?

Answer: Yes, they will cover this cost which forms part of their tenancy agreement between the company and Government of Jersey – Jersey property Holdings).

Upon a proposition by Neil Macdonald, seconded by Carol Robinson (also of Ghost Kitchen Limited), the Assembly unanimously agreed that the 1<sup>st</sup> and 3<sup>rd</sup> Liquor Licences be granted subject to checks being carried out by the Fire Service and Department of Health and all or any conditions, are met.

Connétable Lewis advised the applicants to appear before the Licensing Bench at the Royal Court on Thursday, 21st March 2024, for the hearing of their application.

Connétable Lewis thanked everyone for their attendance.

There being no further business the meeting was closed.
