<p>ITEM 1</p>	<p>Ruth Wainwright, Finance Director of Randalls, addressed the Assembly to present an application on behalf of Oaklands Lodge Hotel Ltd for the grant of a First Category Liquor Licence for The Bagot Inn, Georgetown Road, St Saviour. She informed the Assembly that the current tenant's lease is expiring and Oaklands Lodge Hotel Ltd will be taking over the lease. She confirmed that the required checks have been completed by the Fire Service and the Department of Health.</p> <p>On a proposition by Catherine Perry-Overbury, seconded by Sharon Reid the Assembly unanimously agreed to recommend the application be granted.</p> <p>Connétable Lews advised the applicant to appear before the Licensing Bench at the Royal Court on Thursday 26 September 2024 for the hearing of their application.</p>
