ITEM 1	The minutes of the previous Parish Assembly held on 28 May 2024 were proposed by Roads Inspector Stephen Wyatt, seconded by Deputy Ferey and unanimously agreed by the Assembly.
ITEM 2	<p>On a proposition by the Chairman of the Rates Committee, Tom Gales, seconded by Lesley Norton, ADVOCATE JULIAN CLYDE-SMITH was unanimously elected to act as a member of the Rates Assessment Committee. Mr. Gales thanked Advocate Clyde-Smith for putting himself forward and expressed gratitude to retiring Rates Assessor Jill Moody for her six years of service.</p> <p>The Constable also thanked Advocate Clyde-Smith for volunteering for this role.</p>
ITEM 3	On a proposition by Centenier Steven Laffoley-Edwards, seconded by Lynda Townsend, MR. JAMES ROBERT HATCHER was unanimously elected as a Constable's Officer for the Vingtaine de Petite Longueville. Centenier Laffoley-Edwards informed the Assembly that, due to being called off-island for work, Mr. Hatcher was unable to attend the Assembly. However, he confirmed that he and the Connétable had met with Mr. Hatcher and that all necessary vetting checks had been carried out.
ITEM 4	Connétable Lewis presented Vingtenier Nigel Tanner with an eighteen-year Long Service Award for his service to the Parish, having joined St Saviour in 2004. Connétable Lewis thanked him for his loyalty, dedication, and long service to the Parish and presented him with the award.
