St Saviour's Parish Hall, St Saviour's Hill, La Grande Route de St Martin, La Route de Maufant, , Rue du Pont, La Rue de la Boucterie, Rue du Ponterrin, Rue du Chateau Clairval, La Fosse a l'Ecrivain, La Grande Route de St Martin, La Rue du Moulin, Mont Sohier, Les Routeurs, La Grande Route de St Martin, La Rue des Pigneaux, La Rue de la Commune, Princes Tower Road, La Rue Du Tapon, La Rue St Thomas, La Rue Messervy, Longueville Road, La Rue des Pres, Plat Douet Road, Les Varines, Croix Besnard, La Rue de Beauvoir, Les Varines, Wellington Road, Maison St Louis and Bon Air Lane, St Saviour's Parish Hall.
