<b>ITEM 1</b>	The minutes of the Parish Assembly held on 30 September 2024 were proposed by Deputy Ferey and seconded by Deputy Kovacs and agreed by the Assembly.



<p><b>ITEM 2</b></p>	<p>On a proposition by Beverley Layton, seconded by Vingtenier Hardy, James Hatcher was elected as a Vingtenier for the Vingtaine Petite Longueville.</p> <p>Connétable Lewis warned Mr Hatcher to appear before the Royal Court on Friday 8 November 2024 at 10 a.m. in order to swear the customary Oath of Office.</p>
<p><b>ITEM 3</b></p>	<p>The Connétable proposed by reading the proposition as follows:-</p> <p>In light of the decision of the Assembly held on 30 September 2024 to defer consideration of clause “c” of the proposition in respect of the Maisons Connétable Ozouf Fund, to now consider and, if deemed advisable, approve the following amended proposition which includes new wording for clause “c”:-</p> <p style="padding-left: 40px;">c) The funds currently held and future contributions to the Maisons Connétable Ozouf (MCO) Fund shall primarily be used to assist parishioners of St Saviour, or those with strong ties to the Parish, in obtaining housing. Additionally, the funds may also be used to provide new public or green spaces within St Saviour. Any expenditure of money held in the MCO Fund that is not for the purpose of operating the properties known as the “Maisons Connétable Ozouf” must be pre-approved by a resolution of a Parish Assembly</p> <p>The Connétable then asked for a Secunder in order for the item to be debated. This was Seconded by Procureur Le Quesne.</p> <p>The Connétable then opened the floor for questions.</p> <p>On a proposition by Peter Mourant to amend the proposition by adding the words “in the Parish” after the words “in obtaining housing” in clause c) and seconded by Deputy Ferey the amendment to the Proposition was passed.</p> <p>Deputy Ozouf, after apologising for his lateness to the meeting, addressed the Assembly reminding the Assembly that he has been deeply invested in the project from the very start and Proposed an amendment to the amendment as he has concerns over the wording of clause “c” which in his view limits the fund’s secondary use to “public or green spaces” and does not sufficiently capture the original intent. To address these concerns, he proposed revised wording for clause “c” in that “community facilities” should be added.</p> <p>There was further discussion regarding the wording and how it may be interpreted in the future.</p> <p>The Proposition with both amendments were accepted by Connétable Lewis and Procureur Le Quesne and were put to the Assembly with 12 votes in favour and none against.</p>
