1. INTRODUCTION & DECLARATIONS OF INTEREST

The Chair opened the meeting, welcoming all members and expressing gratitude for their attendance. Apologies were received from Paul Houze.

2. TO APPROVE MINUTES OF THE PREVIOUS MEETING

The approval of the minutes from the previous meeting was deferred to the next meeting.

3. GREEN LANES

KL opened the meeting, convened solely to consider the potential introduction of Green Lanes within the Parish.

The committee engaged in a general discussion on the background, relevant legislation and enforcement challenges associated with Green Lanes. It was agreed that any introduction should be purposeful. A key consideration was connectivity with existing Green Lanes in neighbouring parishes, and the intention to create safer and more confident use of lanes by pedestrians and cyclists.

The committee reviewed a range of lanes and roads within the Parish, along with correspondence received from parishioners suggesting areas for inclusion.

The following provisional Green Lane routes were proposed:

Route 1: From the junction of La Route de la Hougue Bie, via La Rue de la Chouquetterie, to Les Vaux, continuing along La Rue St Julien to the junction with La Rue de la Bachauderie. Proposed by MO, seconded by ME.

Route 2: From the junction of La Rue du Trot to Rue de Ponterrin, into La Rue du Vieux Menage. Although La Rue du Pont would not form part of the Green Lane, it would serve as a connecting cycle route to Trinity. Proposed by SP, seconded by MO. It was further agreed that traffic flow on Rue de Ponterrin should remain unchanged. Proposed by MO, seconded by SP.

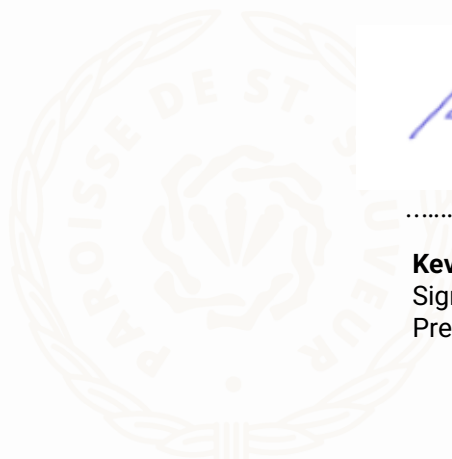
Route 3: From the junction of Rue du Pont, along La Rue de la Guilleaumerie, to the junction with La Rue du Ponterrin. Proposed by MO, seconded by ME.

It was agreed that these three routes would be treated as a provisional first phase, allowing the committee to gauge feedback from parishioners before considering further routes.

The Executive Officer was instructed to prepare a clear map showing only the agreed routes and their connectivity with neighbouring parishes. This will be presented at the next committee meeting before being made available to the public.

4. NEXT MEETING & CLOSING OF MEETING

The Connétable thanked all attendees and closed the meeting at 11.40 a.m. The next meeting is scheduled for **Wednesday 18 June 2025 at 9:30 a.m.**
